At said place and time, and promptly thereafter, all Bids that have been duly received will be publicly opened and read aloud. The Contract provides for the construction of: The scope of services for the project is to provide an NSF-approved coating to two (2) sand filtration tanks, removal and replacement of filter underdrains, and removal and replacement of filter media at the South Water Treatment Plant for Carter Lake Filter Plant. The coating of the tanks shall include all Work necessary to prepare the concrete and steel walls, floors, and steel trough for paint within the Filters 17 and 18. The walls, floors, and steel trough shall be blasted in accordance with specifications and painted in accordance with specifications. The filter media and filter underdrains portion will include all Work necessary for removal and replacement of underdrains and media for the two (2) filters with owner-provided underdrains and media, including the unloading of underdrains from the delivery carrier. Included in this scope is the removal, inspection and replacement of the media from the clarifier in Filter Basin 17 and 18. Screen and beam removal will be required to obtain access to the media. Included in the preparation of Work, is setting up a containment area to prevent the dust from escaping and causing issues outside of the working area. The final product shall be two (2) filter tanks and steel troughs coated with an NSF paint, new underdrains, and new media. Contractor will be responsible for disposal of old materials not retained by the owner.
